A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM FINAL ANNUAL REPORT FOR FISCAL YEAR 2018/2019; APPROVING INTERIM ANNUAL REPORTS FOR FISCAL YEARS 2019/2020 AND 2020/2021 TO THE FLORIDA HOUSING FINANCE CORPORATION PURSUANT TO THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM ACT; AUTHORIZING APPROPRIATE CITY OFFICIALS TO EXECUTE ALL REQUIRED DOCUMENTS AND CERTIFICATIONS.

WHEREAS, the State of Florida enacted the William E. Sadowski Affordable Housing Act, Chapter 92-317 of Florida Session Laws, allocating a portion of documentary stamp taxes on deeds to local governments for the development and maintenance of affordable housing; and

WHEREAS, the State Housing Initiatives Partnership Act ("Act"), Sections 420.907-420.9079, Florida Statutes, and Rule 67-37 of the Florida Administrative Code require local governments to develop a one- to three-year Local Housing Assistance Plan outlining how allocated funds will be used; and

WHEREAS, the Act further requires local governments to annually report on the new and existing housing that benefits from awards made pursuant to the Act; and

WHEREAS, the Department of Development Services, Community Development Division has prepared the attached State Housing Initiatives Partnership Program Final Annual Report for Fiscal Year 2018/2019, and Interim Annual Report for Fiscal Year 2019/2020 and 2020/2021 ("SHIP-AR") for transmittal to the Florida Housing Finance Corporation, as required; and

WHEREAS, the City Commission finds that it is in the best interest of the citizens and residents of the City to submit the attached SHIP-AR for review and approval by the Florida Housing Finance Corporation in order to satisfy the requirements of the SHIP Act.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

That it approves the attached final annual SHIP-AR for Florida Fiscal Section 2: Year 2018/2019 and interim Annual Reports for Florida Fiscal Years 2019/2020 and 2020/2021.

Section 3: That the appropriate City officials are authorized to execute all documents and certifications required by the Florida Housing Finance Corporation as they relate to the attached SHIP-AR and to take such actions necessary to implement the attached SHIP-AR.
