A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, TENTATIVELY FIXING THE AMOUNT AND RATE OF TAXATION FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2021, AND MAKING THE TAX LEVY FOR THE YEAR 2021.

WHEREAS, the total valuation of property both real and personal in the City of Hollywood, subject to assessment for taxation to raise revenue for the fiscal year beginning October 1, 2021 and ending September 30, 2022, as certified by the Broward County Property Appraiser, is \$18,938,419,616; and

WHEREAS, the City Commission, in accordance with §200.065, Florida Statutes, is required at this time to fix the ad valorem tax millage rate and amount pursuant to and in accordance with applicable law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That based upon the taxable value of real and personal properties in Hollywood, Florida, as certified by the Broward County Property Appraiser, there is tentatively levied upon all taxable property in the City of Hollywood, both real and personal, in conformity with the Constitution of the State of Florida and Statutes declaratory thereof, a tax of 7.4810 mills on the dollar of taxable valuation for the period beginning January 1, 2021 and ending December 31, 2021 for the benefit of the General Fund for the fiscal year beginning October 1, 2021 and ending September 30, 2022.

<u>Section 3</u>: That the tentative operating and capital millage rate is 7.4810, which is 4.39% above the rolled-back rate of 7.1663 mills.

<u>Section 4</u>: That the voted debt service millage rate for the General Obligation Bond projects for FY 2022 is 0.4156 mills, for a total proposed millage rate of 7.8966 mills.

<u>Section 5</u>: That all resolutions or parts of resolutions in conflict are repealed to the extent of such conflict.
