ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING CHAPTER 99 OF THE CODE OF ORDINANCES ENTITLED "MUNICIPAL BEACH" TO AMEND THE DAYS AND HOURS OF ACCESS TO THE DOG BEACH.

WHEREAS, Chapter 99 of the Code of Ordinances establishes Municipal Beach regulations; and

WHEREAS, the City wishes to revise Section 99.05(B) pertaining to the Dog Beach hours of operation to better accommodate users of the beach year-round; and

WHEREAS, the City wishes to amend Section 99.05(B)(1) regarding access to the Dog Beach by adding Mondays through Thursdays from 9:00 a.m. to 5:00 p.m. year-round at no charge; and

WHEREAS, the City wishes to amend Section 99.05(B)(4), which requires all users of the Hollywood Dog Beach to execute a form releasing the City from liability and holding the City harmless.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Ordinance.

<u>Section 2</u>: That Chapter 99 of the Code of Ordinances entitled "Municipal Beach" is hereby amended as follows:

TITLE IX: GENERAL REGULATIONS

* * *

CHAPTER 99. MUNICIPAL BEACH

Coding: Words in struck through type are deletions from existing text; words <u>underscored</u> are additions to existing text.

§ 99.05 HOLLYWOOD DOG BEACH.

(A) The Hollywood Dog Beach shall be located between Custer Street and Pershing Street on Hollywood Beach. Any owner of a dog shall be permitted to bring his/her dog to the Hollywood Dog Beach for land and aquatic activities in the designated area during the time period set forth in division (B) below. Dogs shall not be permitted in any other area of the beach as set forth in § 99.03(K).

(B) Rules and regulations.

(1) Access to the Hollywood Dog Beach shall be <u>Monday through</u> <u>Thursday from 9 a.m. to 5 p.m.</u> restricted to <u>and on</u> Fridays, Saturdays and Sundays-<u>The, the</u> hours of operation for the Hollywood Dog Beach for those days shall be as follows:

(a) During Daylight Savings Time: 4:00 p.m. to 8:00 p.m.

(b) During Non-daylight Savings Time: 3:00 p.m. to 7:00 p.m.

(2) Each dog owner wishing to enter the Hollywood Dog Beach <u>on</u> <u>Friday, Saturday or Sunday</u> shall apply to the Director of Department of Parks, Recreation and Cultural Arts or his/her designee for the issuance of a pass and shall submit with such application documentation that the dog has a then current county tag. No dog shall be permitted on the Hollywood Dog Beach <u>on Friday, Saturday or Sunday</u> unless the owner has a valid pass for that dog.

(3) All dogs shall be required to be on a leash or under voice command inside the Dog Beach.

(4) All rules posted at the Hollywood Dog Beach shall be adhered to and strictly enforced. All users of the Hollywood Dog Beach shall be required to execute a form releasing the city from liability, holding the city harmless from liability and agreeing to abide by the applicable rules.

<u>Section 3</u>: That it is the intention of the City Commission and it is ordained that the provisions of this Ordinance shall be made a part of the Code of Ordinances of the City of Hollywood, Florida, and the sections of this Code may be renumbered to accomplish such intention.

<u>Section 4</u>: That if any word, phrase, clause, subsection or section of this Ordinance is for any reason held unconstitutional or invalid, such invalidity shall not affect the validity of any remaining portions of this Ordinance.

<u>Section 5</u>: That all sections or parts of sections of the Code of Ordinances, all ordinances or parts of ordinances, and all resolutions or parts of resolutions in conflict are repealed to the extent of such conflict.

<u>Section 6</u>: That this Ordinance shall be in full force and effect immediately upon its passage and adoption.
