A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A CONTRACT WITH RIC-MAN INTERNATIONAL, INC. FOR CONSTRUCTION SERVICES RELATED TO THE 30 INCH RAW WATER MAIN REPAIR AT THE WATER TREATMENT PLANT IN AN AMOUNT NOT TO EXCEED \$257,800.00, INCLUSIVE OF CONTINGENCY FUNDS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO UTILIZE CONTINGENCY FUNDS FOR UNDEFINED CONDITIONS, IF NECESSARY AND JUSTIFIED, IN AN AMOUNT NOT TO EXCEED \$75,000.00.

WHEREAS, the City's Water Treatment Plant ("WTP") is a 59.5 million gallon per day ("mgd") facility that typically treats 78% of raw water withdrawn from the Biscayne Aquifer, and 22% of raw water allocation from the Floridan Aquifer; and

WHEREAS, Department of Public Utilities ("Department") staff recently noticed a joint leaking at the WTP, from the 30 inch cast iron raw water main that was originally installed in 1952 to supply raw water from Biscayne aquifer wells; and

WHEREAS, several temporary repair methods were evaluated, and none of them could be successfully implemented in-house due to challenges, including limited clearance between the 30 inch pipe and two adjacent electric manholes and the duct bank crossing over the 30 inch pipe; and

WHEREAS, Department staff encased the leaking joint in flowable fill to mitigate the risk of the pipe bursting; and

WHEREAS, on June 17, 2021, Department staff prepared bid documents and advertised the project, soliciting qualified construction services for the 30 Inch Raw Water Main Repair, and on July 15, 2021, four bid proposals were received at the Office of the City Clerk and were publicly opened, with the following results:

WHEREAS, after thoroughly evaluating the bid proposals for compliance with the contract documents, Department staff determined that Ric-Man International, Inc. is the lowest responsive and responsible bidder; and

WHEREAS, on July 22, 2021, a Notice of Intent to Award related to the project was posted on the City's website and on BidSync, and resulted in no bid protests; and

WHEREAS, the Department Director and the Assistant Director of Financial Services for Procurement recommend that the City Commission approve and authorize the appropriate City officials to execute the attached contract with Ric-Man International, Inc., in an amount not to exceed \$257,800.00, for the construction of the 30 Inch Raw Water Main Repair; and

WHEREAS, there is an allowance for undefined conditions in the amount of \$75,000.00 as contingency funding that is included in the total contract price of \$257,800.00; and

WHEREAS, it is recommended that the City Commission authorize the City Manager or designee to approve the utilization of the contingency funds for undefined conditions, if necessary and justified, in an amount not to exceed \$75,000.00; and

WHEREAS, funding was included in the amended FY 2021 Capital Improvement Plan, and is available in account number 442.409901.53600.599901.000000.000.000; and

WHEREAS, the estimated time to complete the construction services will be 90 days from the Notice to Proceed issuance date.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached contract with Ric-Man International, Inc., together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That it authorizes the City Manager or designee to approve the utilization of contingency funds for undefined conditions, if necessary and justified, in an amount not to exceed \$75,000.00.
