MOTION PASSED UNANIMOUSLY BY VOICE VOTE, WITH THE CONDITION THE APPLICANT WORK WITH STAFF TO CONSIDER INCORPORATING THE FOLLOWING ARCHITECTURAL FEATURES, SUCH AS, TO ALTER THE THICKNESS OF LARGE BEAM ABOVE THE PERFORATED METAL WALL, TO MAKE THE BACK PATIO AND CARPORT COLUMNS ROUND, TRY TO CREATE A HOMOGENOUS LOOK ON THE ELEVATION FACING THE STREET.

REQUEST: Certificate of Appropriateness for Demolition and Design for a single-family home

located within the Lakes Area Historic Multiple Resource Listing District.

MOTION PASSED UNANIMOUSLY BY VOICE VOTE, WITH THE CONDITION THE APPLICANT WORK WITH STAFF TO CONSIDER INCORPORATING ART DECO ELEMENTS FROM THE ORIGINAL STRUCTURE, SUCH AS, CURVING THE SOUTHWEST CORNER OF THE N NORTHLAKE FACADE, PLACING EYEBROWS DIRECTLY AT THE TOP OF THE WINDOWS AND TO TIE THE FRONT AND BACK FAÇADE ARCHITECTURAL STYLE TOGETHER.
