3. P-2018-054 City Manager's Recommended Budget Presentation.

4. R-2018-300

A Resolution Of The City Commission Of The City Of Hollywood, Florida, The Amount And Rate Of Taxation For The Fiscal Year Commencing October 1, 2018, And Making The Tax Levy For The Year 2018.

Mayor Levy read the title of the Resolution: "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, FIXING THE AMOUNT AND RATE OF TAXATION FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2018 AND MAKING THE TAX LEVY FOR THE YEAR 2018."

Mayor Levy stated: "THE PROPOSED MILLAGE RATE SET BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD ON SEPTEMBER 12, 2018 IS 7.4665 MILLS, WHICH IS ESTIMATED TO GENERATE **GENERAL FUND** NET REVENUES OF ONE HUNDRED EIGHTEEN MILLION, TWO HUNDRED AND FORTY-FIVE THOUSAND, SEVEN HUNDRED AND TWO DOLLARS (\$118,245,702.00). THIS MILLAGE RATE REPRESENTS AN 6.88% INCREASE OVER THE ROLLED-BACK RATE OF 6.9857 MILLS."

Mayor Levy announced the public hearing has been advertised in conformance with Florida statutes and City ordinances. The public hearing was opened, being there was no one present who wished to be heard, the public hearing was declared closed.
