1. **R-CRA-2018-50** - A Resolution Of The Hollywood, Florida, Community Redevelopment Agency ("CRA"), Approving The Minutes Of The Regular Community Redevelopment Agency Meeting Of September 5, 2018.

ACTION: Motion was made by Board member Callari to adopt the resolution. The motion was seconded by Board member Sherwood and on voice vote passed 6-0. Board member Hernandez was absent.

2. **R-CRA-2018-51** – A Resolution Of The Hollywood, Florida, Community Redevelopment Agency, ("CRA"), Approving The Minutes Of The Regular Community Redevelopment Agency Meeting Of November 7, 2018.

4. **ACTION:** Motion was made by Board member Callari to adopt the resolution. The motion was **seconded** by Board member Sherwood and on voice vote passed 6-0. Board member Hernandez was absent.
5. **R-CRA-2018-53** - A Resolution Of The Hollywood, Florida, Community Redevelopment Agency, ("CRA"), Authorizing CRA Officials TO Negotiate And Execute An Agreement With Block By Block To Provide A Clean And Safe Ambassador Program And All Necessary Equipment, Materials And Products As Needed For The Estimated Amount Of \$450,000.00; Authorizing The Issuance Of A Blanket Purchase Order With The Highest Ranked Firm For Such Services.

11. **COMMENTS BY BOARD MEMBERS, GENERAL COUNSEL AND EXECUTIVE DIRECTOR**

Board member Shuham, District 1

Harrison Street Parklet

Board member Shuham advised that the Parklet located at the Topsy Boar seems more open and airy.

Code Enforcement

Board member Shuham sent a shout out to John Weitzner, Code Enforcement officer for the beach district, for doing an exceptional job on the beach.

Board member Shuham requested that staff look into the enforcement of safety guidelines among the teenagers who are skateboarding, as the skateboarding startles beachgoers. She would like staff to look into what action can be taken to enforce safety.

Board member Hernandez, District 2

Parklets

Board member Hernandez stated that the parklet located at Topsy Boar is under-utilized and the landscaping needs some care. He suggested that staff look into another location if the current location is not working. He further suggested using color on the wood so that it stands out.

Trolley Circulator

Board member Hernandez stated that he is very excited about the trolley circulator coming to fruition. He further advised that this is a great idea for the City.

Downtown Hollywood

Board member Hernandez stated to his colleagues that Downtown Hollywood looks much blighted. He suggested to his colleagues to hold a workshop to address the issues and concerns and to discuss the future direction of the downtown.

All Board members supported this request.

Board member Callari, District 3

Downtown Workshop

Board member Callari advised that she will cancel her Commission in the Community meeting scheduled in the upcoming month to hold a town hall meeting to address the issues and concerns in the downtown.

Board member Callari also requested that her colleagues work collaboratively with City and CRA staff to combine their efforts and vision for a better downtown.

Hollywood Beach

Board member Callari thanked the CRA and Margaritaville Resort for stepping up and meeting the needs of the residents by providing more police support on Hollywood Beach.

Candy Cane Parade

Board member Callari stated that she will not be attending this year's Candy Cane Parade due to work commitment. She thanked Chair Levy and staff for recommending the candy canes be handed out rather than tossed into the audience. She further advised that she discourages the social media bullying and hopes that we can all reach an amicable solution to next year's parade even if it means changing the location.

Board member Blattner, District 4

Downtown Hollywood

Board member Blattner supported the idea of a downtown workshop and recommended involving the businesses as part of the discussion.

CRA Projects

Board member Blattner requested that the CRA Executive Director provide an update on the 2019 CRA projects that will have a beneficial effect on the taxes.

Downtown Hollywood

Board member Blattner requested that staff provide the rules for music in the downtown district especially electronic music.

Board Member Biederman, District 5

Candy Cane Parade

Board member Biederman extended an invitation to everyone to attend the Candy Cane Parade scheduled on December 8, 2018. He further suggested using the water-soluble straws instead of candy canes.

Downtown Hollywood

Board member Biederman stated that the downtown businesses are going out of business because of poor business plan and/or poor customer service. Board member Biederman further stated that we can create more programs and use Community Development to recruit other businesses.

Business Improvement District

Board member Biederman suggested to staff that the sidewalk pressure cleaning in the downtown district should be handled by the City who would then cite them and the cost reimbursed by the businesses through their annual tax bills.

A1A

Board member Biederman advised staff to be more proactive with all contractors, not only FDOT contractors.

Parklet

Board member Biederman stated that the parklet located at Topsy Boar needs more landscaping. He further suggested that the CRA share the cost of landscaping with the business to make sure that it is well maintained.

Board Member Sherwood, District 6

Board member Sherwood had no further comments.

Candy Cane Parade
