## Explanation:

The Department of Parks, Recreation & Cultural Arts ("PRCA") desires to install a synthetic sports field at Boggs East Sports Field.

On September 27, 2023, Invitation for Bid Number IFB-120-23-GJ ("IFB") was electronically advertised on OpenGov.com to solicit Synthetic Turf Installation at Boggs East Sport Field in accordance with Section 38.43(A) of the Procurement Code.

Upon review of the bids received in response to the IFB, Act Global Americas, Inc. ("Act") met

all bid requirements and was deemed the lowest priced responsive and responsible firm.

The Directors of PRCA and Design and Construction Management recommend that the City Commission authorize the execution of an Agreement with Act to provide the installation of a synthetic sports field, with contingency funds, at Boggs East Sports Field in an amount up to \$1,029,545.00.
