A Resolution Of The City Commission Of The City Of Hollywood, Florida, Authorizing The Appropriate City Officials To Renew The Existing Professional Services Agreement To Provide Structural Engineering Services Between Lakdas/Yohalem Engineering Inc., TRC Worldwide Engineering, Inc. And DeRose Design Consultants, Inc. And The City Of Hollywood, For A One (1) Year Period, Under The Same Terms And Conditions.

Staff Recommends: Approval of the Attached Resolution.

Explanation:

On July 16, 2014, the City Commission passed and adopted Resolution No. R-2014-225 which authorized City Officials to negotiate and execute agreements with the three (3) highest ranked firms for Structural Engineering Services. The firms were:

- Lakdas/Yohalem Engineering, Inc
Fort Lauderdale, FL
- DeRose Design Consultants, Inc.
Pompano Beach, FL
- TRC Worldwide Engineering, Inc.
Plantation, FL

The negotiated agreements were for an initial three (3) years with the right to renew for two (2) subsequent one year terms. This Resolution will allow the firms to renew for the first one (1) year renewal term under the same terms and conditions.

These contracts allow the City to hire firms as needed to consult on capital improvement and maintenance projects. Each contract cannot exceed \$1,000.00.00
