The second regular Commission meeting on Wednesday, June 19, 2024, shall be rescheduled to Tuesday, June 18, 2024, at 1:00 P.M, with citizens' comments at 5:00 P.M., due to Juneteenth.

The first regular Commission Meeting on Wednesday, July 3, 2024, shall have citizens' comments at 5:00 P.M.

The second regular Commission meeting on Wednesday, July 17, 2024, shall be rescheduled to Wednesday, August 28, 2024, at 1:00 P.M. with citizens' comments at 5:00 P.M. By

moving the meetings during the summer it will allow the Commission, staff and residents more time for preparing the next fiscal year's budget.

The first regular Commission meeting on Wednesday, October 2, 2024, shall be rescheduled to Tuesday, October 1, 2024, at 1:00 P.M., due to Rosh Hashanah.

The second regular Commission meeting on Wednesday, October 16, 2024, shall be rescheduled to Wednesday, October 23, 2024, at 1:00 P.M., with citizens' comments at 5:00 P.M. due to Sukkot.

The start time of the second regular Commission meeting on Wednesday, November 20, 2024, shall be rescheduled time from 1:00 PM to 11:00 AM, with citizens' comments at 5:00 PM due to the Swearing-In Ceremony of the newly elected officials.

The first regular Commission Meeting on Wednesday, December 4, 2024, shall have citizens' comments at 5:00 P.M.
