Staff Recommends: Approval of the attached Resolution.

Explanation:

The Hollywood Community Redevelopment Agency ("CRA") Desires to Install Signalized Crosswalks at the Intersection of State Road A1A and Nebraska Street, SR A1A and Carolina Street and SR A1A.

State Road A1A is a major road in the City and the Florida Department of Transportation ("FDOT") has jurisdiction over State Road A1A.

On January 17, 2024, the City Commission of the City of Hollywood, Florida passed and adopted Resolution No. R 2024-18, Approving and Authorizing the City Commission to Execute a Maintenance Memorandum of Agreement ("Agreement") with FDOT for the Upgrading to Black Color, Three Traffic Signal Mast Arms Located at the Intersection of State

Road A1A and Nebraska Street, SR A1A and Carolina Street and SR A1A and Scott Street;
and

On February 17, 2024, the CRA Approved and Adopted Resolution No. R-CRA-2024-05 authorizing the installation of the Carolina Street signalized crosswalk and as a condition for FDOT to issue permit # 2022-C-491-00012 for the three proposed signalized crosswalks, a construction agreement must be approved and executed by the CRA.
