PRCA and DCM desire to apply for the upcoming State of Florida, Division of Arts and Culture Cultural Facilities Program grant in the amount of \$500,000.00. The Cultural Facilities Program grant requires a two-to-one match equivalent to \$1,000,000.00 from the
