Explanation:

The State Housing Initiatives Partnership ("SHIP Act"), Sections 420.907 through 420.9079, Florida Statutes and Rule 67-37, Florida Administrative Code, require local governments to develop a one- to three-year Local Housing Assistance Plan outlining how allocated funds will be used and requiring local governments to annually report on the new and existing housing that benefits from awards made pursuant to the SHIP Act.

To meet this requirement, the Community Development Division has prepared the attached State Housing Initiatives Partnership Program Final Annual Report for Fiscal Year 2019/2020 and Interim Annual Report for Fiscal Year 2020/2021 ("SHIP-AR") for transmittal to the

Florida Housing Finance Corporation.
