A Resolution Of The City Commission Of The City Of Hollywood, Florida, Endorsing The Florida Department Of Transportation's Delivery Of Sidewalk And Bicycle Lane Improvements For A Certain Project Identified In The Five-Year Adopted Work Program Which Fall Within The City Of Hollywood's Jurisdictional Right Of Way, More Specifically The Hollywood Gardens West Sidewalk And Bike Path Project No. 434679-52-01.

Staff Recommends: Approval of the Attached Resolution.

Explanation:

The City Commission supports the completion of missing sidewalk networks and designated bicycle lanes along the City's roadway system to provide safe pedestrian and bicycle pathways to protect residents from the traveling public, and in furtherance of these initiatives, has enacted legislation embracing the "Complete Streets" concept in support of these mobility initiatives.

The Broward Metropolitan Planning Organization (Broward MPO) obtains federal funding to be appropriated towards mobility enhancement projects. Through the Department of Public Work's efforts, the Broward MPO designated full project federal funding towards the Hollywood Gardens West Sidewalk and Bike Project No. 434679-52-01, providing for the construction of all missing sidewalk networks within the Hollywood Gardens West neighborhood which spans from Johnson Street to Hollywood Boulevard and US441 to 56th Avenue, together with the construction of bike lanes along:

- Columbus Parkway and Glenn Parkway within Hollywood Gardens West, Fillmore Street, 58th Avenue, Lincoln Street and Polk Street within the Hollywood Gardens West neighborhood;
- Taft Street from 20<sup>th</sup> Ave to 14th Ave (sidewalk infill and bike sharrow)

In an effort to optimize project implementation and provide cost and time savings, the City, Broward MPO and the Florida Department of Transportation (FDOT) agree delivery of the design, construction and project management services for the above referenced project is best provided for by FDOT. The City must endorse FDOT's delivery of projects which fall within the City jurisdictional right of way. The project is in the preliminary design stage and will come back to the City Commission for approval after the design is complete and the public outreach to the affected communities is performed.
