The City of Hollywood is the owner of a 4,474 square foot building at 5731 Pembroke Road and adjacent 25' wide vacant parcel, which have been operated as a day care facility known as the Sue Gunzburger-Washington Park Child Care Center. Sue Gunzburger-Washington Park Child Care Center is partially impacted by a 100-year Flood Zone. Therefore, The City of Hollywood desires to secure coverage for a flood insurance product for a not to exceed amount of \$907.00.
