A Resolution Of The City Commission Of The City Of Hollywood, Florida, Authorizing The Appropriate City Officials To Renew The Existing Professional Services Agreement To Provide Mechanical, Electrical And Plumbing Engineering Services Between SGM Engineering, Inc., Norman F Bray P.E., Inc. And DeRose Design Consultants, Inc. And The City Of Hollywood, For A One (1) Year Period, Under The Same Terms And Conditions.

Staff Recommends: Approval of the Attached Resolution.

### Explanation:

On July 16, 2014, the City Commission passed and adopted Resolution No. R-2014-224 which authorized City Officials to negotiate and execute agreements with the three (3) highest ranked firms for Mechanical, Electrical and Plumbing Engineering Services. The firms were:

- Norman F Bray P.E., Inc  
Hollywood, FL
- DeRose Design Consultants, Inc.  
Pompano Beach, FL
- SGM Engineering, Inc.

Fort Lauderdale, FL

The negotiated agreements were for an initial three (3) years with the right to renew for two (2) subsequent one year terms. This Resolution will allow the firms to renew for the first one (1) year renewal term under the same terms and conditions.

These contracts allow the City to hire firms as needed to consult on capital improvement and maintenance projects. Each contract cannot exceed \$1,000.00.00
