Utilizing RFP 4344-13-IS and Resolution R-2013-086, the City designated as its broker of record, Arthur J. Gallagher Risk Management Services. Arthur J. Gallagher Risk Management Services solicited and/or obtained quotes from different carriers for the various types of coverage on behalf of the City. The total renewal cost is for a not to exceed amount of \$634,887.00.
