Explanation:

The Department of Information Technology has determined a need for a Senior Systems Analyst through the remaining Fiscal Year 2018.

Section 38.40 (C)(2) of the City's Purchasing Ordinance exempts contracts for professional services involving peculiar skills, such as systems consultants, from the competitive solicitation process.

On January 31, 2018 five firms were solicited to assess interest and obtain pricing for professional temporary services in the field of Senior Systems Analyst: InSight Global, Robert Half International, Inc., MS Consulting, Kforce, and Panorama Consulting.

Robert Half International, Inc. provided the best qualified candidate to meet Information Technology operational requirements.

By approving this resolution, the city of Hollywood will be able to fill this position without

delay.

All applicable procurement sections will be adhered to in accordance with the City of Hollywood Procurement Ordinance.

Funding for the attached agreement has been appropriated and exists in account number xxxxxxxxx.

Funding will be only obligated as labor for professional services which are approved to support city projects.
