A Resolution Of The City Commission Of The City Of Hollywood, Florida, Approving And Authorizing The Appropriate City Officials To Execute A Contract With GPE Engineering And General Contractor Corp. For Construction Services Related To The Wilson Street Parking Improvements In The Amount Of \$199,681.16; Approving An Amendment To The Fiscal Year 2020 Capital Improvement Program.

Staff Recommends: Approval of the attached Resolution.

### Explanation:

There are insufficient on-site parking spaces for Underground Utilities Division staff at their location at 1715 North 21<sup>st</sup> Avenue.

In an effort to mitigate this condition, the Department of Public Utilities staff determined that the best and most reasonable course of action is to provide additional parking spaces along Wilson Street between North 21st Avenue and the alley west of North 20th Avenue.

On August 8, 2019, the Department of Public Utilities staff prepared bid documents and advertised the project, soliciting qualified construction services, and on September 5, 2019, six bid proposals were received at the Office of the City Clerk and were publicly opened at the Southern Regional Wastewater Treatment Plant with the following results:

After thoroughly evaluating the bid proposals for compliance with the contract documents, Department of Public Utilities staff determined the bid proposal received from GPE Engineering and General Contractor Corp. is the lowest responsive and responsible bidder.

A Notice of Intent to Award related to the project was posted on the City's website and on DemandStar on September 11, 2019, and resulted in no bid protests.

The Department of Public Utilities staff recommends that the City Commission authorize the appropriate City officials to execute the attached contract with GPE Engineering and General Contractor Corp.
