A Resolution Of The City Commission Of The City Of Hollywood, Florida, Authorizing The Appropriate City Officials To Execute A Construction Agreement With The Florida Department Of Transportation For Proposed Improvements Along State Road A1A Between Hollywood Boulevard And Sheridan Street To Include Pedestrian Lighting, Landscaping & Irrigation, Hardscape, Aerial Facility Undergrounding, And Installation Of Traffic Signalization At The Northeast Corner Of State Road A1A And Garfield Street.

Staff Recommends: Approval of the Attached Resolution.

Explanation:

State Road A1A is a major road in the City of Hollywood, Florida and the City wishes to install pedestrian lighting, landscaping & irrigation, hardscape, aerial facility undergrounding and installation of traffic signal at northeast corner of State Road A1A and Garfield Street.

The Florida Department of Transportation (FDOT) has jurisdiction over State Road A1A and as a condition of the permit approval, a construction agreement with the Florida Department of Transportation must be approved by the City Commission.

The Construction Agreement allows the City to install pedestrian lighting, landscaping & irrigation, hardscape, aerial facility undergrounding and the installation of a traffic signal at the northeast corner of State Road A1A and Garfield Street, which is under the jurisdiction of the Florida Department of Transportation.

Funding for the construction costs will be paid by the City of Hollywood Community Redevelopment Agency and has been allocated in the Beach CRA FY 20 Account Number 163.639901.552.563010.001105.000.000.
