### Public Safety

Staff Recommends: Approval of the attached Resolution.

### Explanation:

The Police Department submitted an application to the Office of the Attorney General, State of Florida, for the continued funding for a Police Department Victim Advocate. The Victim Advocate assists at crime scene, determines the physical needs of the victim and/or his/her family, refers crime victim to appropriate community resource agencies. Services will include crisis intervention, personal advocacy, information and referral, follow-up contact, assistance with filing crime victim's compensation claims, group support for homicide survivors, assistance with filing for injunctions against violence for stalking, mailing out essential information, acting as a liaison with investigators, telephone and face-to-face communication, and assistance in obtaining police reports for victims.

### Fiscal Impact:

The VOCA Grant funds will be approximately \$94,260.63 with a required in-kind match of approximately \$23,565.17. Notification of award is anticipated in Fiscal Year 2021. If awarded, a separate budget amendment will be presented to Commission to recognize and appropriate the grant award.
