Explanation:

Section 98.050, of the Hollywood Code of Ordinances provides for the construction and/or location of boat docks on City property along portions of North and South Lake;

Alejandro Garcia and Daylen Teresa Abraham (collectively the "Lessee") is the owner of residential property that has requested a Lease with the City for the use of the land and existing boat dock;

Section 98.0501 (B) of the Code of Ordinances provides for an annual lease fee, excluding sales tax of which the current annual fee is \$594.66.

Fiscal Impact:

The City will receive \$594.66 from Alejandro Garcia and Daylen Teresa Abraham the 2020 boat dock lease agreement.
