A Resolution Of The City Commission Of The City Of Hollywood, Florida, Approving And Authorizing The Appropriate City Officials To Execute An Amendment To The Agreement With Sunshine After School Care, Inc. Staff Recommends: Approval of the Resolution.

Explanation:

On April 20, 2016, The City authorized the execution of an agreement with Sunshine After School Child Care, Inc. ("Sunshine") for the operations of the City's Aftercare and Summer Camp Program Services at David Park Community Center and Driftwood Community Center; the existing agreement between the City and Sunshine expires on June 09, 2021.

The novel coronavirus ("COVID-19") and the new requirements set forth by the Center for

Disease Control, the State of Florida, and Broward County limiting facility capacities to operate a summer camp and aftercare program make it no longer fiscally feasible for Sunshine to operate under the current 25% gross receipt payment from summer camp revenue and Sunshine is seeking to reduce the required payment to 10% of gross receipts.

For continuity of operations, site knowledge and experience, the Parks, Recreation and Cultural Arts Department is recommending execution of the amendment to the agreement with Sunshine.

The Parks, Recreation and Cultural Arts Department also recommends authorizing the City Manager or his designee to negotiate the rate reduction of future payments for the 2020 fall school aftercare program with a minimum of no less than five percent and a maximum registration fee of \$250.00 per period in order to continue to provide school aftercare program services.

Fiscal Impact:

This Resolution seeks authorization to renew the agreement with Sunshine After School Care to provide summer camp for 2020. The proposed renewal will reduce the payments to be received by the City from 25% to 10% of gross receipts. This reduction will result in an estimated revenue loss of \$8,800.00 in FY 2020. This Resolution also seeks authorization to negotiate the rate for fall 2020 as a result of the impact of COVID-19.
