Staff Recommends: Approval of the attached Ordinance.

Explanation:

The following changes were made to the ordinance between the first and second reading based on Commission comments and Staff recommendations:

- Title - changed "public property" to "City property;" changed 97.11 to 97.12 to account for new 97.11 Exemptions
- Definitions - added definitions for City facility and City property; shortened the definition for single-use plastics by removing some of the example packaging items
- 97.08 (B), 97.09 (B) - changed the start of the enforcement period

- 97.09 - removed “rights-of-way”
- 97.09 (A) - changed “rights-of-way” to “City property”
- 97.09 (C) - removed “rights-of-way”
- 97.11 - added exemptions to account for states of emergency and emergency response
- 97.11 - changed to 97.12 to account for 97.11 Exemptions
- Section 4 - added the effective date

Fiscal Impact:

Approval of this ordinance will not fiscally impact the City as this is a proposal to revise the Code pertaining to offensive littering and sets forth policies related to vendor contracts, extension and renewal of those contracts, special events, and City property.
