Staff Recommends: Approval of the attached Resolution.

Explanation:

Southern Regional Wastewater Treatment Plant (SRWWTP) is a 60 million gallon per day wastewater treatment facility that uses multiple treatment processes to treat wastewater and produces high quality effluent. As the wastewater undergoes through multiple treatment processes, a final product called "Biosolids" is produced. The City utilizes high calcium granular lime to stabilize Biosolids to produces the highest quality of Biosolids - Class AA Exception Quality (EQ) - that are marketed under the trade name "Revinu" and sold as fertilizer. This product is used on sod farms and eliminates tens of thousands of tons of

Biosolids disposed in landfills.

On September 9, 2020, the City of Tamarac entered into an agreement with Carmeuse Lime & Stone, Inc. to furnish, deliver, and discharge high calcium granular quicklime. This contract was competitively bid by the City of Tamarac, who acted as lead agency on behalf of the Southeast Florida Governmental Purchasing Group Cooperation, pursuant to Bid Number 20-21B. This agreement is effective from November 1, 2020 through October 31, 2023, with the option to renew for three (3) additional one year periods. The estimated

The Director of Public Utilities and the Chief Procurement Officer recommend that the City Commission approve and authorize the issuance of a Blanket Purchase Agreement to Carmeuse Lime & Stone Inc. for High Calcium Granular Lime at the Southern Regional Wastewater Treatment Plant in an estimated annual amount or \$1,614,994.50.

The Department of Public Utilities staff will manage this project. No additional staff is needed as a result of this project.

Funding for this service is available in the FY 2021 Operating Budget account number 442.400601.53600.552330.000000.000.000, and will be budgeted in subsequent fiscal years' operating budget subject to the approval and adoption by the City Commission.
