Staff Recommends: Approval of the Attached Resolution.

Explanation:

The Department of Public Works, Fleet Management Division, on behalf of the Department of Public Utilities and the Department of Public Works, requires the purchase of five new vehicles to replace vehicles that have reached or surpassed their life expectancy and road worthiness by age, mileage and wear, and can no longer be relied upon to perform at required operational levels.

The Department of Public Works is requesting the purchase of two new vehicles: one new 2021 Chevrolet Silverado 5500HD Crew Cab 2YD. Dump Body Truck WT, DRW (CC56043/C5B), Specification #17 and one 2021 Chevrolet Silverado 5500HD Crew Cab Stake Body Truck WT, DRW (CC56043), Specification #17. The Department of Public Utilities is requesting the purchase of three new 2022 Ford F-550 4x2 Truck with Crane Body and 7,500 lb. Crane, Specification #37 (F5G).

The requested vehicles were competitively bid through the Florida Sheriff Association Bid Number FSA20-VEH18.0 and award was made to Duval Fleet and Palmetto Ford Truck Sales, Inc. for a term effective October 1, 2020 through September 30, 2022. Duval Fleet and Palmetto Ford Truck Sales, Inc. has agreed to provide to the City, under the exact pricing, terms and conditions the five new vehicles.
