Due to three terms on the Civil Service Board expiring on June 30, 2023, and one vacant position, the Office of the City Clerk advertised to fill upcoming Board vacancies.

The board consists of Zulma Collazo, serving as an individual employed in the private sector in a personnel administration position, whose term is expiring June 30, 2023; Dr. Jalane Meloun, serving as an individual employed in the private sector in a non-management position, whose term is expiring June 30, 2023; Michael Anton, serving as an individual previously or presently employed in the public sector, whose term is expiring June 30, 2023; a vacant position which has not been filled for an individual employed or previously employed in the private sector in a management section, the term expires June 30, 2024; Samuel Bentolila, serving as an individual self-employed or previously self-employed, whose term expires June 30, 2024.

The request for this board appointment is being submitted out of the regular board appointment cycle due to an appeal regarding a termination that the Civil Service Board
