A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING AND AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE FIRST AMENDMENT TO THE AGREEMENT WITH EASTERSEALS OF SOUTH FLORIDA, INC. TO FUND ADULT DAY CARE SERVICES IN THE AMOUNT OF \$250,000.00 FUNDED BY THE STATE 2026-2027 APPROPRIATIONS.

WHEREAS, on October 9, 2025, the City Commission passed and adopted Resolution No. R-2025-346, approving an agreement with Easterseals of South Florida, Inc. (“ESSF”) for Adult Day Care Services at Oak Lake Community Center from January 1, 2026 through December 31, 2031; and

WHEREAS, ESSF was funded to provide services through a City award of State 2025-2026 appropriation funds allocated through the Area Agency on Aging of Broward County, Inc. for the Hollywood Adult Day Care Program in an amount up to \$249,109.00 for the initial period of March 1, 2026 through June 30, 2026; and

WHEREAS, the City has been awarded State 2026-2027 appropriation funding for the Hollywood Adult Day Care Program in the amount up to \$250,000.00 for the period of July 1, 2026 through June 30, 2027; and

WHEREAS, the Director of the Department of Parks, Recreation and Cultural Arts recommends that the City Commission approve and authorize the First Amendment to the Agreement with ESSF to fund adult day care services in an amount up to \$250,000.00 for the period of July 1, 2026 through June 30, 2027 funded through the State’s 2026-2027 appropriation funds allocated by the Area Agency on Aging of Broward County, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of a First Amendment to the Agreement with ESSF, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.
