A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING FIVE
MEMBERS TO THE HISPANIC AFFAIRS COUNCIL.

WHEREAS, on April 16, 2025, the Hollywood City Commission passed and adopted Resolution R-2025-100, establishing a Hispanic Affairs Council to act as a liaison between the Hispanic community and the City, and establishing the current composition of the Council as five members and two alternates of Hispanic background, who shall be selected by the majority vote of the City Commission for the initial term of the resolution and thereafter. Following the initial terms, all appointments/reappointments thereafter shall be for three-year terms; and

WHEREAS, this Council would inform the City Commission and staff of specific issues of concern to Hollywood's Hispanic community and propose implementation goals for those issues; and

WHEREAS, the following members: Cristina Moinelo, Alejandra Palacios, and Maribel Ruiz, in the members category, expire on June 30, 2026; and

WHEREAS, there are two vacant alternate positions that were not filled, and they expire on June 30, 2026; and

WHEREAS, the City Clerk provided notice to the public that positions are available on the Hispanic Affairs Council and solicited interest forms from citizens for the available vacancies; and
