A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ACCEPT BROWARD BEHAVIORAL HEALTH COALITION (BBHC) CORE GRANT FUNDING IN THE AMOUNT OF \$327,782.20, WITH NO REQUIRED MATCHING FUNDS; APPROVING AND AUTHORIZING THE EXECUTION, BY THE APPROPRIATE CITY OFFICIALS, OF A GRANT AGREEMENT WITH THE BBHC; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL APPLICABLE GRANT DOCUMENTS; AND AMENDING THE FISCAL YEAR 2026 OPERATING BUDGET.

WHEREAS, the City of Hollywood Fire Rescue & Beach Safety Department ("Department") administers programs that improve community health and provide services to individuals with substance use disorders and behavioral health needs; and

WHEREAS, the Broward Behavioral Health Coalition ("BBHC") administers CORE Grant funding to support behavioral health initiatives, including Mobile Integrated Health ("MIH") and substance use disorder programs, throughout Broward County; and

WHEREAS, the Department has been approved, pending execution of the grant agreement, to receive BBHC CORE Grant funding in the amount of \$327,782.20 for Fiscal Year 2026; and

WHEREAS, these funds were originally awarded to the City in Fiscal Year 2025 but were returned to BBHC because the Department was unable to fully expend the funds during the original grant period; and

WHEREAS, BBHC has reallocated the funding to the Department for Fiscal Year 2026 to continue supporting the City's MIH Program and substance use disorder initiatives; and

WHEREAS, the grant funding will now be used to support eligible program expenses, including personnel, program operations, outreach, supplies, and other allowable expenditures in accordance with the grant agreement; and

WHEREAS, the City wishes to enter into a grant agreement with the BBHC to accept and administer CORE funding for the period July 1, 2026 through June 30, 2027; and

WHEREAS, the Fire Chief recommends that the City authorize the appropriate City

officials to accept the BBHC CORE Grant award and execute all applicable grant documents; and

WHEREAS, the City of Hollywood's Fiscal Year 2026 Operating Budget was adopted and approved by the City Commission pursuant to Resolution R-2025-335 at the 2nd Public Budget Hearing on September 25, 2025; and

WHEREAS, this Resolution seeks to amend the budget ("Amendments") as detailed in the attached Exhibit "1."

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated into this Resolution.

Section 2: That the City Manager is authorized to accept the grant, if awarded, provided that the City Manager shall have the discretion to refuse the grant in those circumstances where she determines it is in the best interest of the City to do so, in which case she shall advise the City Commission of her intention to refuse the grant.

Section 3: That it approves and authorizes the execution, by the appropriate City officials, of a grant agreement with the BBHC for the CORE program, together with such non-material changes as may be subsequently agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 4: That it authorizes the appropriate City officials to execute all applicable grant documents and agreements in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That the amendments to the Fiscal Year 2026 Operating Budget for the Fiscal Year beginning October 1, 2025, and set forth in detail in the attached Exhibit "1" are adopted and authorized as Amendments to the Operating Budget of the Fire Grants Fund (Fund118).

Section 6: That the Department of Financial Services is authorized to create and establish in the appropriate fund the necessary accounts to recognize the receipt of grant funding and to appropriate grant related funding as may be required.

Section 7: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
