A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING FIVE
MEMBERS TO THE EDUCATION ADVISORY COMMITTEE.

WHEREAS, on March 21, 2001, the City Commission passed and adopted Resolution R-2001-93 establishing the Education Advisory Committee (“Committee”); and

WHEREAS, R-2001-93 was subsequently amended by Resolutions R-2002-241, R-2003-144, R-2003-373, R-2004-203, R-2005-299, R-2007-421, R-2009-188, R-2011-143, R-2012-186, R-2013-088, R-2015-262, R-2018-176, R-2023-175, and R-2024-221 establishing the current composition of the Committee as four Teacher Members, seven Regular Members, and two Student Alternate Members; and

WHEREAS, members of the Committee must reside, work or attend school in Hollywood and be recognized for their broad countywide interest in education; and

WHEREAS, persons of diverse perspectives shall be represented on the Committee, including parents of pre-school or school-age children, educators, businesspeople, and persons with child development or education-related backgrounds; and

WHEREAS, there is one Teacher Member position with a term ending June 30, 2026, due to the removal of Carlos Gonzalez Garrido; and,

WHEREAS, Allain McGuffie serves in the capacity of a Teacher Member, and his term expires on June 30, 2026; and

WHEREAS, there is one Regular Member position with a term ending June 30, 2026, following Adam Roberti’s decision to decline the appointment; and

WHEREAS, there are two vacant Student Alternate Member positions with terms expiring on June 30, 2028, due to the resignations of David Liebowitz and Brook Manassee; and

WHEREAS, the City Clerk provided notice to the public that positions are available on the Committee and solicited interest forms from citizens to fill available vacancies; and

WHEREAS, the following candidates have expressed interest and are qualified for appointment to the Committee as a Teacher Member:
