Dear Ms. Gomez:

On behalf of Bridge Asset Management, LLC, (“Applicant”), please consider this letter as a summary of community outreach efforts undertaken in relation to the rezoning application filed to develop the property generally located on the south side of Jackson Street, west of Dixie Highway (“Property”) in the City of Hollywood, and more specifically identified in the enclosed materials.

Outreach 1

At 6:00 p.m. on January 6, 2025, we held a virtual community meeting. An invitation was sent to all property owners within 500 feet of the Property. The notification package is attached as **Exhibit A**. The meeting participant list/sign-in documentation is attached as **Exhibit B**.

During the meeting, Elizabeth Somerstein, representative for the Applicant, presented the rezoning proposal using a PowerPoint presentation. The presentation materials are attached as **Exhibit C**. Two attendees spoke during the meeting and documentation of discussion using the city’s comment matrix is attached as **Exhibit D**. The meeting concluded with Ms. Somerstein thanking everyone for attending the meeting and advising the participants to reach out with any questions. It was also announced that a second outreach meeting was scheduled to take place on January 26, 2026.

As the meeting was concluding, we noticed a late participant log in. After the meeting, we reached out via email asking them to contact us with any questions they may have. No response was received. A copy of that e-mail is attached as **Exhibit E**.

Outreach 2

At 6:00 p.m. on January 26, 2025, we held a virtual community meeting. An invitation was sent to all property owners within 500 feet of the Property. The notification package is attached as **Exhibit F**. The meeting registration list is attached as **Exhibit G** and the participant list/sign-in documentation is attached as **Exhibit H**.

During the meeting, Elizabeth Somerstein, representative for the Applicant, presented the rezoning proposal using a PowerPoint presentation. The presentation materials are the same as those presented at the first outreach meeting held on January 6, 2026 except that the date was updated to January 26, 2026. See attached **Exhibit I**. Aside from the Applicant's representatives, one (1) member of the community attended the meeting. Documentation of discussion using the city's comment matrix is attached as **Exhibit J**. 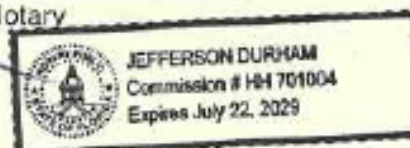

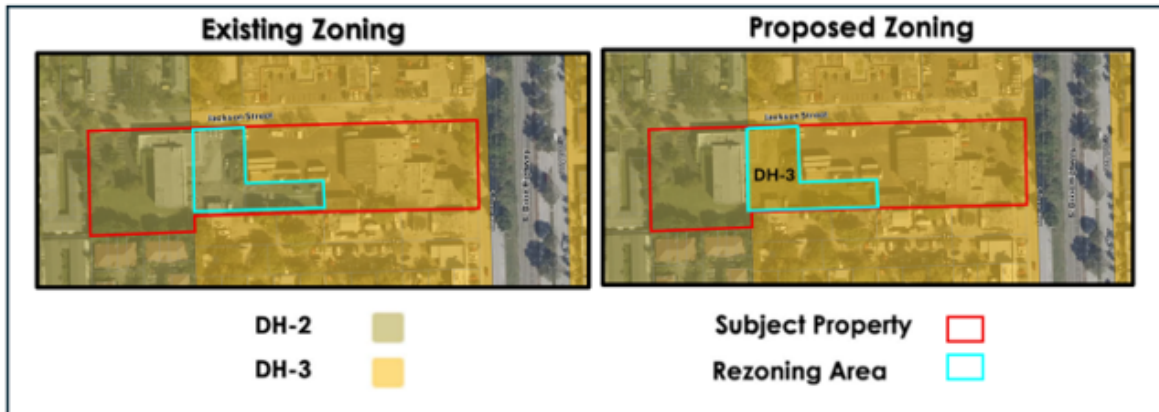

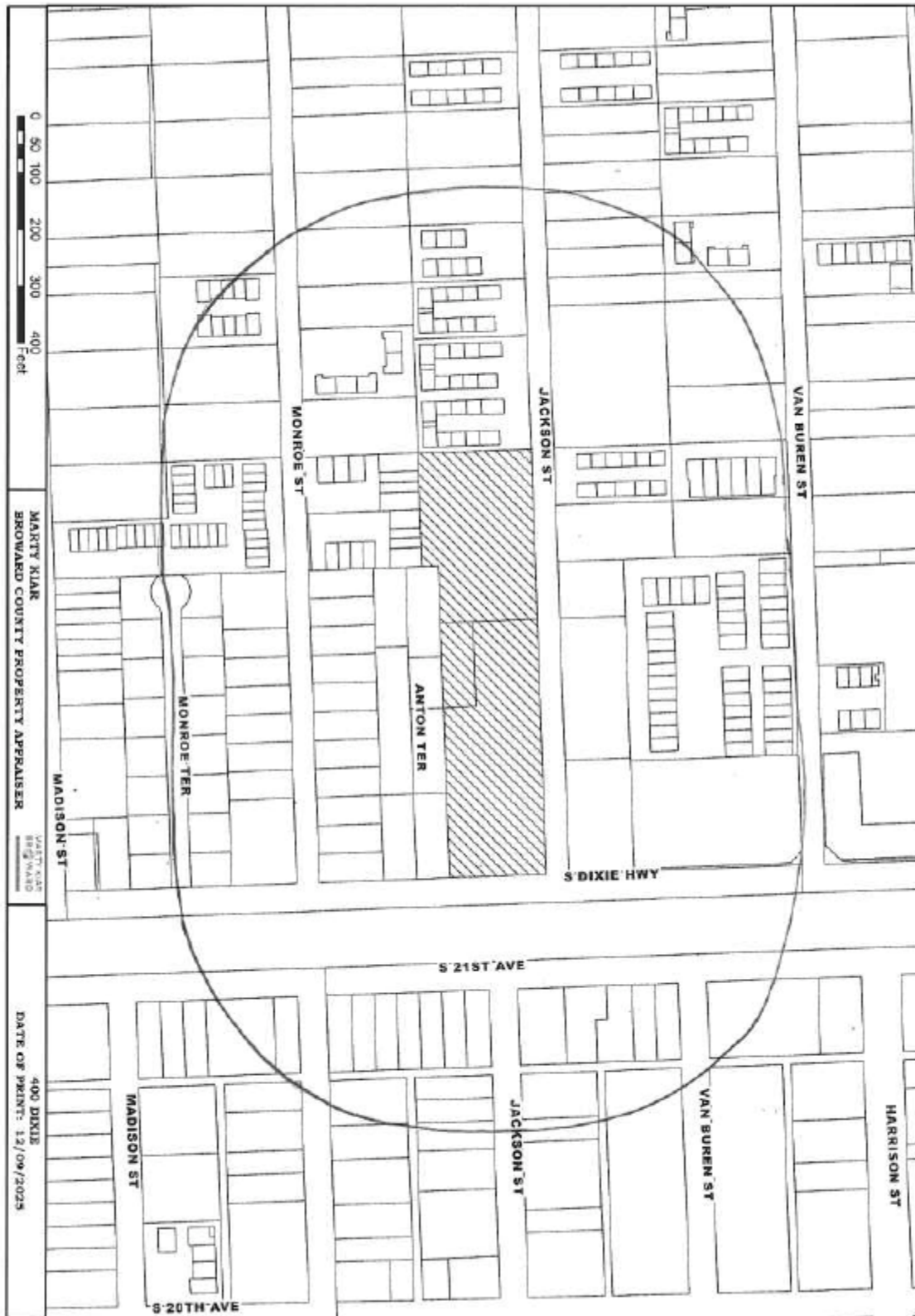
