A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO TAKE ACTIONS AS DEEMED NECESSARY REGARDING THE AGREEMENT WITH BROWARD COUNTY ON THE SHORE PROTECTION PROJECT, SEGMENT III.

WHEREAS, on October 21, 2020, the City Commission approved Resolution R-2020-278, adopting the City's Dune Master Plan; and

WHEREAS, on February 21, 2024, the City Commission approved Resolution R-2024-057, amending the maximum height of dune crest elevation to 8.4 NAVD to meet the Broward County requirements to complete the dune design for the Shore Protection Project III ("Segment III SPP"); and

WHEREAS, on October 9, 2025, the City Commission approved Resolution R-2025-358, approving the Agreement with Broward County Regarding the Segment III SPP, Segment III for the access and use of City property for the Segment III SPP ("Agreement"); and

WHEREAS, during construction, concerns arose pertaining to certain elements of the Segment III SPP such as ratio of recreational beach width to dune width, post and rope locations, access points, and other design and public safety considerations; and

WHEREAS, on April 15, 2026, the City Commission directed the County to stop work, City staff to review the matter with the County, and City staff to bring back an agenda item for the City Commission to consider regarding the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it authorizes the City Manager to take action as deemed necessary by the City Commission regarding modifications to the Agreement.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
