AN ORDINANCE OF THE CITY OF HOLLYWOOD, FLORIDA, AMENDING THE CITY'S EXISTING COMPREHENSIVE PLAN BY AMENDING THE POTABLE WATER SUB-ELEMENT OF THE UTILITIES ELEMENT TO ADOPT BY REFERENCE THE WATER SUPPLY FACILITIES WORK PLAN 2025 UPDATE IN ACCORDANCE WITH SECTION 163.3177(6)(C)(3), FLORIDA STATUTES; AS MORE SPECIFICALLY SET FORTH IN EXHIBIT "A"; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 163.3177(6)(c)(3), Florida Statutes, local governments are required to update their Water Supply Work Plans and Comprehensive Plans within 18 months after the District's Governing Board approves the Regional Water Supply Plan for that area; and

WHEREAS, the South Florida Water Management District updated the Lower East Coast Water Supply Plan, which was approved on September 24, 2024; and

WHEREAS, in 2020, the City Commission passed and adopted Ordinance No. O-2020-11, which amended the City's adopted Comprehensive Plan to add a new Water Supply Plan to the Potable Water Sub-Element and related amendments to modify objectives and/or policies in the Land Use Element, Conservation Element, Utilities Element, Intergovernmental Coordination Element, and Capital Improvements Element for water supply planning; and

WHEREAS, Carollo Engineers, Inc., on behalf of the Department of Public Utilities, developed the City of Hollywood's Water Supply Facilities Work Plan ("WSFWP") 2025 Update, which include characterization of the City of Hollywood's service area, updating of population projections, development of water demand forecasts, evaluating adequacy of water supply sources, assessing of existing conservation and reuse efforts, documenting of capital improvements and water supply projects; and

WHEREAS, the City of Hollywood elected to reference the Water Supply Facilities Work Plan 2025 Update by amending Section 7 of the Potable Water Sub-Element, within the City's Existing Comprehensive Plan Utilities Element; and

WHEREAS, the WSFWP 2025 Update establishes that the City of Hollywood continues to successfully implement water conservation efforts, which have assisted the City to reduce its per capita consumption from 114 gpcd (gallons per capita per day) (2018) to 98.9 gpcd (2025); and

WHEREAS, pursuant to state law, the City of Hollywood Planning and Development Board, acting in its capacity as the Local Planning Agency, held a duly noticed public hearing on February 10, 2026, to review the proposed comprehensive plan amendments and has forwarded a recommendation of approval to the City Commission; and

WHEREAS, in accordance with Section 163.3184(3)(b) and (c), Florida Statutes, the City Commission has conducted two duly advertised public hearings on the proposed amendments to the City's Comprehensive Plan, including the review of objections, recommendations, and comments of the respective reviewing agencies, if any; and

WHEREAS, the City Commission, after due consideration of all matters, finds that the proposed amendments are consistent with the City of Hollywood's Comprehensive Plan and the Broward County Comprehensive Plan, the South Florida Regional Planning Council Regional Plan, and comply with the requirements of state law; and

WHEREAS, the City Commission, after review of the recommendations of City staff, the Local Planning Agency, comments made at the public hearing, and careful consideration of the issues, finds that the proposed amendments are in the best interest of the health, safety, and welfare of the citizens of the City of Hollywood.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and incorporated in this Ordinance.

Section 2: That the Potable Water Supply Element of the Utilities Element of the City's Comprehensive Plan, set forth in the attached Exhibit "A," is adopted.

Section 3: That the WSFWP 2025 Update, set forth in the attached Exhibit "B," is adopted.

Section 4: That pursuant to Section 163.3184(3)(c)(2), Florida Statutes, the attached plan amendments for the Potable Water Supply Element of the Utilities Element set forth in Exhibit "A," and the WSFWP 2025 Update set forth in Exhibit "B," shall be transmitted to the Florida Department of Commerce for review and issuance of an Objections, Recommendations and Comments report and to other local government agencies that provided timely comments within 10 days of the adoption of this Ordinance.

Section 5: That the effective date of this Ordinance shall be 31 days after the state land planning agency notifies the City that the plan amendment package is complete unless there is a timely challenge to the plan amendment, whereby the amendment does not become effective until the state land planning agency or the Administrative Commission enters a final order determining the adopted amendment is in compliance.
