

RESOLUTION NO. R-2025-222

A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPROVING THE ADOPTION
OF THE DEPARTMENT OF PUBLIC UTILITIES
STORMWATER MASTER PLAN.

WHEREAS, the Public Utilities Department ("Department") owns and maintains the City's stormwater system, a complex system comprised of numerous parts, including catch basins, drainage pipes, exfiltration trenches, outfalls, swales, retention ponds, and stormwater pump stations; and

WHEREAS, the Department has the responsibility for planning, regulating, designing, constructing, operating, and maintaining this stormwater system; and

WHEREAS, an updated Stormwater Master Plan ("SWMP") is necessary to effectively fulfill the City's responsibility to provide a high level of service to residents, comply with federal, state, county, and local regulations, address sea level rise and storm surge concerns, accommodate growth and economic development, and protect public health, safety, and the environment; and

WHEREAS, the Department has therefore developed an updated comprehensive SWMP; and

WHEREAS, the SWMP will allow the City to develop and implement a Citywide Comprehensive Capital Improvement Plan identifying areas most in need of flood drainage mitigation and water quality improvement; and

WHEREAS, the SWMP incorporates compliance with the City's Resiliency and Vulnerability Strategies and Initiatives, in addition to complying with Florida Statute 380.093 and the National Flood Insurance Program Community Rating System ("NFIP-CRS") requirements, and implementation of the SWMP also provides NFIP-CRS credits that translate into flood insurance premium discounts; and

WHEREAS, the Department recommends that the City Commission approve the adoption of the updated SWMP.

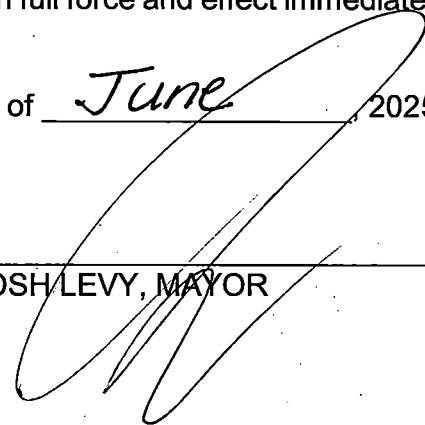
