A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ISSUE A PURCHASE ORDER TO GLADE & GROVE SUPPLY CO, LLC FOR THE PURCHASE OF A NEW HOLLAND AGRICULTURAL TRACTOR MODEL TS6.120 HC WITH BEACH TIRES IN AN AMOUNT UP TO \$131,441.17 BASED UPON SOURCEWELL CONTRACT NO. 082923 IN ACCORDANCE WITH SECTION 38.41(C)(5) OF THE PROCUREMENT CODE (PIGGYBACK).

WHEREAS, the Department of Public Works (“Public Works”) seeks to procure a New Holland Agricultural Tractor, model TS6.120 HC, equipped with beach tires (“Tractor”), to support the removal of sargassum seaweed from the sands of Hollywood Beach, as well as to perform beach grooming, sand refinement, and general maintenance activities; and

WHEREAS, the Tractor’s pricing and specifications were competitively solicited by Sourcewell Solicitation RFP No. 082923 on July 11, 2023, and awarded to CNH Industrial America LLC, (“CNH”) under Sourcewell Contract No. 082923 (“Contract”); and

WHEREAS, the current term of the Contract is from November 13, 2023, through October 11, 2027, with an option to renew the Contract for up to three additional one-year extensions; and

WHEREAS, CNH has agreed to extend the same pricing to the City under the terms and conditions set forth in the Contract; and

WHEREAS, Glade & Grove Supply Co, LLC (“Glade & Grove”) is an authorized dealership for CNH under the Contract; and

WHEREAS, Section 38.41(C)(5) of the Procurement Code allows the Chief Procurement Officer to procure, without formal solicitation procedures, all goods, supplies, materials, equipment, and services that are the subject of contracts with the state, its political subdivisions, the United States government, other governmental entities, or a corporation not for profit whose members are governmental entities, public officers, or any combination thereof (“piggyback”), provided that the goods, supplies, materials, equipment, or services are the subject of a price schedule negotiated by the entities listed above and is based strictly on competitive bids, quotations, or competitive proposals and not on any preference and such utilization of other governmental entities contracts shall be permitted only during the term of the other governmental entity’s contract; and

WHEREAS, the Director of Public Works and the Director of Procurement and Performance Management recommend that the City Commission approve and authorize the issuance of a Purchase Order to Glade & Grove for a Tractor in an amount up to \$131,441.17; and

WHEREAS, funding for this purchase is available in account number 163.638507.55200.564530.000000.000.000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the issuance, by the appropriate City officials, of a Purchase Order to Glade & Grove together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
