A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH BROWARD COUNTY SHOULD THE CITY OF HOLLYWOOD BE AWARDED AS A RECIPIENT OF THE 2026 WORLD CUP EVENT FUNDING IN AN AMOUNT UP TO \$12,500.00; AUTHORIZING THE REQUIRED ONE TO ONE MATCHING FUNDS TO BE PAID FROM THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS 2026 OPERATIONAL BUDGET; FURTHER AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE ALL OTHER APPLICABLE DOCUMENTS AND AGREEMENTS.

WHEREAS, the Department of Parks, Recreation and Cultural Arts (“PRCA”) is seeking to fund two 2026 World Cup Watch Party events in Downtown Hollywood; and

WHEREAS, the Broward County 2026 World Cup Municipal Event Support Grant is available for the funding of 2026 World Cup events, including watch parties or viewing of the 2026 World Cup matches; and

WHEREAS, the maximum reimbursement available to the Participating Cities under this grant shall not exceed an amount equal to \$12,500.00; and

WHEREAS, the grant requires a one-to-one match from the Recipient; and

WHEREAS, the Director of PRCA recommends that the City Commission approve and authorize the appropriate City officials to accept, if awarded the 2026 World Cup Municipal Event Support Grant, authorize the required matching funds, and authorize the appropriate City officials to execute all other applicable documents and agreements; and

WHEREAS, PRCA will provide the in-kind match utilizing account number 001.300601.57200.549110.000000.000.000;.and

WHEREAS, the Broward County 2026 World Cup Municipal Event Support Grant will require a future budget amendment to recognize the Recipient award once notification of an award is received.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA.

Section 1: That the foregoing “WHEREAS” clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That the City Manager is authorized to accept, if awarded, and execute an agreement with Broward County, together with such non-material changes as may be acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney, provided that the City Manager shall have the discretion to refuse the funding in those circumstances where she determines it is in the best interest of the City to do so, in which case she shall advise the City Commission of her intention to refuse the funding.

Section 3: That it authorizes the required one-to-one matching funds pursuant to the 2026 World Cup Municipal Event Support Grant Program Guidelines.

Section 4: That it authorizes the appropriate City officials to execute all applicable documents and agreements in a form acceptable to the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 5: That the Department of Financial Services is authorized to create and establish in the appropriate fund the necessary accounts to recognize the receipt of grant funding and to appropriate grant-related funding as may be required.

Section 6: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
