- Prior to meeting starting, Patricia stated that virtual community meetings should not be

held in one day when there are more than 1 project

- Luis confirmed that projects have been presented this way without prior issues.
- Luis La Rosa presented project. Showed Site Plan, Floor Plans and Elevations
- Luis La Rosa opened questions to participants.
- Marcela: Stated concerns about traffic and how City of Hollywood plans to control the traffic increase which is already a concern due to the school in front
 - Luis: stated that the City and engineers constantly perform traffic studies to address these concerns. Mentioned 5 feet dedication on Van Buren Street for future projects that is being taken into account but there is no further information to be provided from Architect's end as to how these studies are being applied towards a solution
 - Helen: Asked for clarification on explanation
 - Luis: showed in plans what the 5 feet dedication means/implies for this project
- Helen: stated that the project does not fit into the structure of the neighborhood
 - Luis: mentioned similar 4 story project that is being built with no variances being requested
 - Helen: mentioned project is in CRA district
 - Luis: confirmed its DH2 which allows 1.75 FAR - this project is not exceeding the FAR/height/setbacks are benign respected/giving up 5 feet of property
 - Helen: stated that with all rentals going up, residents are looking into parking lot
- Marcela: asked how many parking spaces will be in 1st floor
 - Luis: 50/ 49 with one parking lift (2 - 3 bedrooms) / 1 bedrooms have an individual spot. Every unit has their minimum. 5 guests instead of the 4 required
- Helen: Asked how many 1 bedrooms
 - Luis: 27 one bedrooms, 3 two bedrooms, 6 three bedrooms
- Helen: Asked how people will know about these meetings
 - Luis: mentioned that for the 3 individual properties, everyone within 500 feet was noticed
- Helen: referred to another project Luis has
 - Luis: 12 units
 - Marcela: Mentioned 12 units in that project compared to 36
 - Luis: Explained lot difference of 7,000 square feet vs 20,000 square feet. higher floor area ratio because its DH2
 - Helen: Concern of looking into people's backyard/no privacy/party on rooftops/downtown being surrounded by high rises/neighborhoods surrounded with rats
 - Luis: mentioned RAC has been established
 - Helen: when it was first established it was done for Downtown/mentioned CRA/ruining of people's lives
- Helen: Asked about sewers
 - Luis: mentioned sewer extension to property and where it is located
- Patricia: stated "you need to put it pretty"

- Luis: mentioned finalizing the mural
 - Patricia: stated it was about the building itself /adding color
- Judith: asked about the trees protected by the state
- Helen: Asked about sewer
 - Luis: explained how this will be connected
- Asked about project timeframe
 - Luis: March or April Planning Development Board. It takes about 4 to 6 months to get a building permit. Notifications will be sent. Looking at October, November of next year.
- Judith: Asked what will happen to those that are displaced. Comments were made on project not going to be afforded by people in the area that is in/being too nice for the neighborhood
- Helen: Mentioned that people can go to the meetings to express their concerns
- Marcela: (who is next door) asked how their septic would be affected.
 - Luis: the sewer, the addition, or the extension of the sewer doesn't affect your septic system at all.
- Judith: asked about who is painting the mural
 - Luis: mentioned it is a concept. It will be more tropical and the colors that Patricia mentioned previously will be discussed with the client
- Marcella: units for sale/rent?
 - Luis: normally clients do rentals but these will be condos
- Luis asked for contact information and it was provided
- Project presentation ended and moved on to the next one

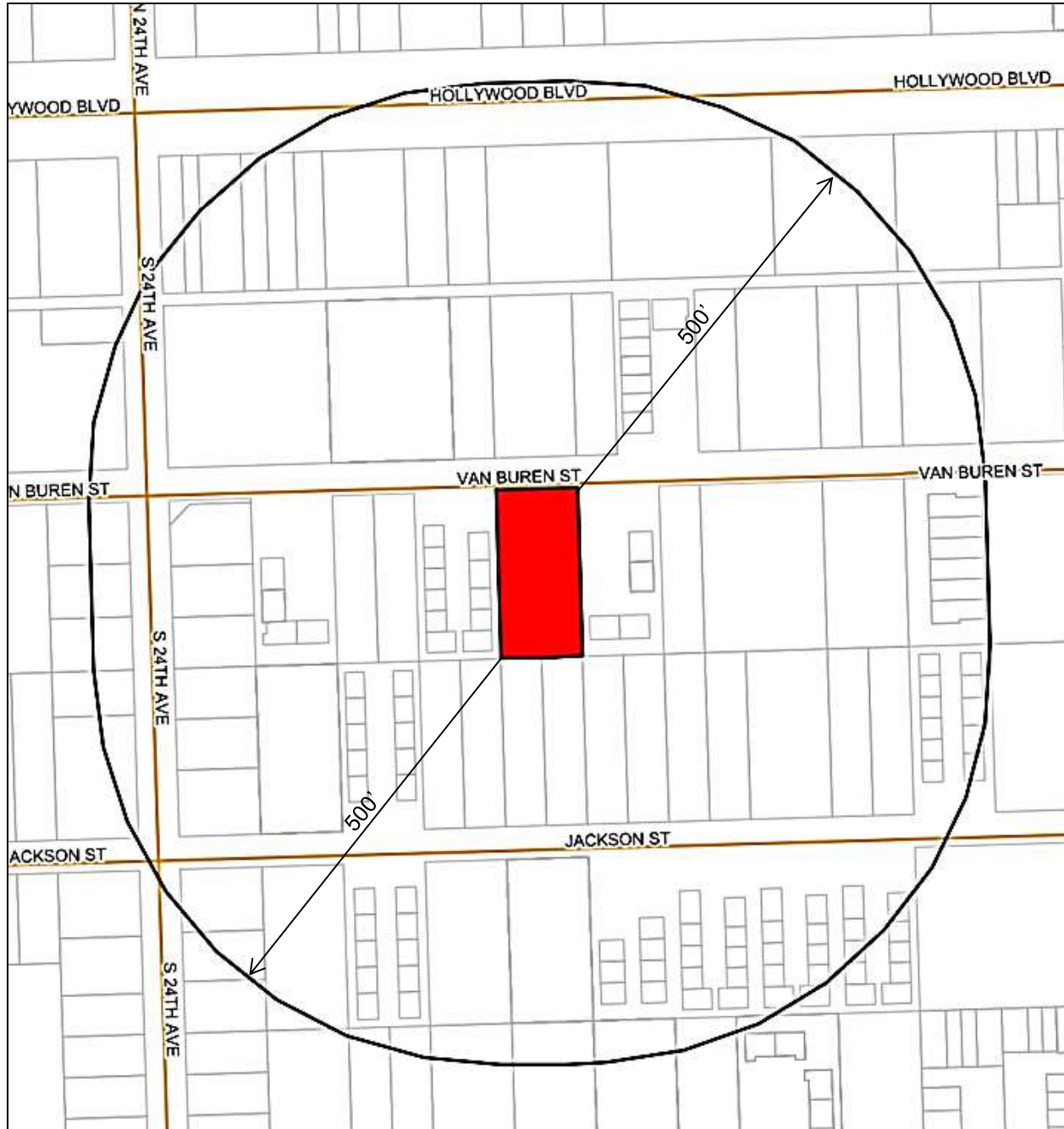
