A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE A MASTER AGREEMENT FOR PRESCRIPTION MEDICATION AND SUPPLIES FROM THE PHARMACY FOR FIRE RESCUE UNITS AND ISSUE A BLANKET PURCHASE AGREEMENT TO SOUTH BROWARD HOSPITAL DISTRICT D/B/A MEMORIAL HEALTHCARE SYSTEM FOR THE PURCHASE OF EMERGENCY MEDICAL SUPPLIES AND PHARMACEUTICALS IN AN ANNUAL AMOUNT UP TO \$175,000.00 FOR A THREE-YEAR PERIOD UP TO \$525,000.00 IN ACCORDANCE WITH SECTION 38.41(C)(9) OF THE PROCUREMENT CODE. (BEST INTEREST)

WHEREAS, the City of Hollywood maintains a Fire Rescue and Beach Safety Department ("Department"), which provides critical services for the safety and protection of the residents of Hollywood; and

WHEREAS, the Department has purchased pharmaceuticals and medical supplies from the South Broward Hospital District, d/b/a Memorial Healthcare System ("Memorial"), which has consistently provided superior product availability, reliability, and support for the Department's emergency medical operations; and

WHEREAS, Memorial is easily accessible by the Department for any of the required medical supplies and pharmaceuticals; and

WHEREAS, the period of performance during which the desired medical supplies and pharmaceuticals will be acquired is for a three-year period for an annual amount up to \$175,000.00; and

WHEREAS, while staff worked with Memorial it was determined that, rather than maintaining the previously separate agreements for medical supplies and for pharmaceuticals, Memorial and the Department would consolidate these services into a single comprehensive agreement; and

WHEREAS, this combined agreement includes all supplies under a unified contract structure and ensures continuity of service, making it in the best interest of the City to continue its relationship with Memorial for the provision of both medical supplies and pharmaceuticals; and

WHEREAS, Section 38.41(C)(9) of the Procurement Code states that when the City Commission declares by a five-sevenths (5/7ths) affirmative vote that competitive bidding and competitive proposals are not in the best interest of the City, such purchases are exempt from competitive bidding and competitive proposal requirements; and

WHEREAS, the Department wishes to execute the Master Agreement for Prescription Medication and Supplies from the Pharmacy for Fire Rescue Units ("Master Agreement") and issue a Blanket Purchase Agreement for a three-year period, during which the desired medical supplies and pharmaceuticals will be acquired; and

WHEREAS, the Fire Chief and Chief Procurement Officer recommend that the City Commission approve and authorize the execution of the Master Agreement and issue a Blanket Purchase Agreement to Memorial for pharmaceuticals in an annual amount up to \$175,000.00; and

WHEREAS, a portion of the funding for this Blanket Purchase Agreement is available in the Fiscal Year 2026 Operating Budget in account number 001.215101.52200.552320.000000.000.000 and will be budgeted in subsequent fiscal years.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it approves and authorizes the execution, by the appropriate City officials, of the attached Master Agreement for Prescription Medication and Supplies From the Pharmacy for Fire Rescue Units and Blanket Purchase Agreement to South Broward Hospital District d/b/a Memorial Healthcare System, together with such non-material changes as may subsequently be agreed to by the City Manager and approved as to form and legal sufficiency by the City Attorney.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.
