

**FIRST AMENDMENT TO THE AGREEMENT BETWEEN  
THE CITY OF HOLLYWOOD, FLORIDA  
AND EASTERSEALS OF SOUTH FLORIDA, INC. FOR THE BUSINESS OF ADULT  
DAY CARE SERVICES AT OAK LAKE COMMUNITY CENTER**

THIS FIRST AMENDMENT is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2026, by and between the City of Hollywood, Florida ("City") and Easterseals of South Florida, Inc. ("ESSF").

WHEREAS, the City and ESSF entered into an Agreement for the business of adult day care services at Oak Lake Community Center ("Original Agreement"); and

WHEREAS, pursuant to the provisions of the Agreement, the City agreed to enter into a five (5) year agreement; and

WHEREAS, the City has received funding in an amount up to \$250,000.00 from the State of Florida 2026-2027 State Appropriations through the Area Agency on Aging of Broward County, Inc for the Hollywood Adult Day Care Program.

WHEREAS, the CITY and ESSF, wish to amend the Agreement, for the purpose of utilizing state funding to continue to fund adult day care services for an additional year from July 1, 2026 through June 30, 2027.

NOW, THEREFORE, in consideration of the mutual terms, conditions, promises and covenants contained herein, it is hereby agreed by and between the parties hereto, as follows: Incorporation of the following term to the agreement.

**ARTICLE 1 - RECITALS**

1.01 Recitals. The Parties agree that the foregoing recitals are true and correct and that such recitals are incorporated herein by reference.

**ARTICLE 3 – CONSIDERATIONS**

3. The following provisions shall be added to this Sections of the Agreement dated January 21, 2026, by interlineation, as follows:

3.4 The City shall be responsible to pay Contractor the Unit of Service fee as provided in the Service Program Agreement per Unit of Service delivered by Contractor with the required client/caregiver documentation. The maximum compensation for services provided under this Agreement shall not exceed Two Hundred Fifty Thousand and 00/100 Dollars (\$250,000.00) for services rendered for the period of July 1, 2026, through June 30, 2027, and in which this Agreement is in effect. The funds City pays to Contractor are received by City through an

allocation from the Area Agency on Aging of Broward County, Inc. to the City pursuant to the Service Program Agreement.
