Chartered by Boys & Girls Clubs of America in 1965, Boys & Girls Clubs of Broward County (BGCBC) has been a cornerstone of youth development in the community for six decades. Today, BGCBC operates 11 Clubs and 5 Teen Centers across Broward County, providing safe, supportive environments for over 8,000 young people annually, ages 6-18. BGCBC's mission is to enable all young people, especially those who need us most, to reach their full potential as productive, caring, responsible citizens. Through comprehensive out-of-school time programming, the organization addresses critical community needs by offering academic support, career exploration, leadership development, health and wellness initiatives, and workforce readiness training.

At the heart of BGCBC's work is the commitment to providing a world-class Club experience that ensures success is within reach for every child. Members can access academic enrichment, nutritious meals and snacks mentorship opportunities, and engaging activities promoting healthy lifestyles and lifelong skills. BGCBC empowers youth to graduate high school with a plan for the future, build leadership and character, and develop the confidence to thrive in school, work, and life. A four-star rated Charity Navigator organization for the 14th consecutive year, BGCBC maintains a proven track record of fiscal responsibility and is recognized as a leading advocate for youth

With the demonstrated success of impactful programming and strong community partnerships, BGCBC remains dedicated to creating brighter futures for Broward County's youth. Our equation for success includes four pillars of impact:

1. **Academic Success** - Excellence is the standard at Boys & Girls Clubs of Broward County, and that commitment is reflected in the organization's academic success programming. Members receive homework help, tutoring, and hands-on learning experiences that strengthen core skills and support school achievement. Programs foster a love for learning while keeping youth on track to graduate and pursue higher education Clubs provide access to computers with web-based software to boost reading and math proficiency, along with high-quality instruction and supplemental activities designed to help every member excel in school.
2. **Character & Leadership** - programming empowers youth to develop social awareness, strengthen leadership skills, and grow into responsible, engaged citizens. Members participate in meaningful projects focused on service to the Club and community, education, health and fitness, and social recreation. These experiences inspire character growth while fostering a lifelong commitment to making a positive impact.
3. **Health & Well-being** - programming supports the physical, emotional, and social development of every member. Through the Snack and Supper Program, youth receive a free nutritious snack and hot supper Monday through Saturday, addressing food insecurity and promoting healthy eating habits. Members also engage in daily fitness activities, sports leagues, and nutrition education, all designed to encourage active living and informed lifestyle choices. In addition, programs that focus on stress reduction, resiliency skills, and building positive relationships help youth navigate challenges and maintain mental well-being. Together, these efforts create a strong foundation for lifelong health.
4. **Life & Workforce Readiness**- programming equips youth with essential skills for success in school, careers, and life. Through engaging activities, members explore their interests and passions, develop

employability skills, and apply their knowledge to real-world experiences. Programs offer hands-on learning in resume writing, financial literacy, interview preparation, and college planning, helping youth build a strong foundation for future achievement. Career exposure opportunities and college tours further broaden their horizons and prepare them for post-secondary success.

Together, these comprehensive programs and services reflect Boys & Girls Clubs of Broward County's unwavering commitment to empowering youth, strengthening communities, and creating great futures for those who need us most.

PROGRAM INFORMATION

1. How does your proposed project address the LETF Category (see above) as well as the Hollywood Police Department's Priority Area?

Attending the Boys & Girls Clubs plays a powerful role in diverting youth from the criminal justice system and promoting long-term crime prevention. By providing a structured, supportive, and enriching environment during the critical hours after school, when youth are most likely to engage in risky behaviors, the Club becomes a safe haven that keeps young people engaged in positive activities and surrounded by caring mentors.

After-school programs like those offered by the Boys & Girls Clubs of Broward County serve as critical intervention points in the lives of young people. They provide safe, structured, and supervised environments during the hours when youth are most at risk of engaging in risky behaviors. These programs reduce the likelihood of involvement in crime by offering positive alternatives that promote stability and personal growth. Through academic support, youth improve school performance and reduce their chances of dropping out. Enrichment opportunities in sports, arts, and STEM spark curiosity, build valuable life skills, and encourage self-expression. Equally important, mentorship and counseling help address emotional and behavioral challenges, fostering resilience and emotional well-being. Extensive research underscores the impact of these programs-youth who consistently participate are significantly less likely to be arrested, more likely to graduate and tend to be more engaged and invested in their communities. Our programs are intentionally designed to build decision-making skills, emotional intelligence, and resilience.

The Club also partners closely with local law enforcement, the Department of Juvenile Justice, and community agencies to provide prevention-based programming that proactively addresses the root causes of delinquent behavior. These partnerships create a bridge between youth and the systems that serve them, fostering trust and reducing the likelihood of negative interactions with law enforcement. Through daily transportation services, we ensure that youth can access our Clubs and the vital resources they offer.

Based on a study conducted by Columbia University, the establishment of Boys & Girls Clubs in underserved areas directly correlates with reductions in juvenile crime rates. By giving young people consistent access to mentorship, structure, and opportunity, the Boys & Girls Club reduces risk factors associated with juvenile crime-such as lack of supervision, academic failure, and low self-esteem-and replaces them with protective factors like positive adult relationships, goal setting, and a strong sense of belonging. This holistic approach not only helps youth stay on the right path but also contributes to safer, more connected communities for all.

2. Why is this funding needed (What community problem does it address)? What data suggests this program should be implemented with this population or in this geographical location?

There is an urgent and growing need for accessible, high-quality after-school programs in Broward County, particularly those that provide safe, structured environments during the critical hours following school dismissal. Such programs play a vital role in preventing juvenile delinquency, fostering positive youth development, and addressing risk factors that are prevalent in many communities. According to the Florida Department of Juvenile Justice, Broward County experienced a 3% increase in juvenile arrests between the 2023-24 and 2024-25 fiscal years.. This increase reflects a troubling statewide trend and underscores the importance of sustained, proactive intervention. Broward County consistently ranks among the highest in Florida for juvenile arrests, with common offenses including theft, assault, and drug-related activities, many of which occur during the hours immediately after school.

Research from the National Afterschool Alliance and the Office of Juvenile Justice and Delinquency Prevention (OJJDP) confirms that the hours between 3 p.m. and 6 p.m. are the peak times for youth involvement in risky behavior and violent crime. Alarming, 64% of violent crimes committed by youth on school days occur during this timeframe. During these hours, when parental supervision may be limited, youth are more susceptible to negative influences, making preventive programs a critical line of defense.

Despite this well-documented need, many families lack access to safe, affordable after-school care. The need for equitable access to preventive programs is more pressing than ever. Quality after-school programs, like those offered by the Boys & Girls Clubs of Broward County (BGCBC), offer youth not only safety and supervision but also opportunities for academic enrichment, social-emotional learning, mentorship, and personal growth. These programs reduce the likelihood of juvenile justice involvement and promote long-term success by helping youth stay on track academically, pursue healthy lifestyles, and develop leadership skills.

BGCBC is committed to ensuring that all children can access the life-changing resources the Club provides. By doing so, BGCBC continues to play a pivotal role in community safety, educational equity, and youth empowerment.

Open to youth ages 6-18 years old, the Marti Huizenga Boys & Girls Club provides out-of-school time activities and programming that meet the needs and interests of its members. BGCBC's equation for success includes four pillars of impact: Academic Success, Health & Well-being, Character & Leadership, and Life & Workforce Readiness. It has been the goal of BGCBC to provide a world-class Club experience that assures success is within reach of every young person who walks through our doors. We want all members to graduate from high school with a plan for the future; demonstrate good character and citizenship by participating in leadership training and volunteering in community service projects; and engage in sports and other physical activities that promote a healthy lifestyle.

Marti Huizenga Boys & Girls Club provides a safe, welcoming, and inspiring environment where every young person feels seen, heard, and valued. More than just a place to go after school, our Club is a vibrant community built on trust, mentorship, and opportunity. At the heart of our success are dedicated staff who build meaningful relationships with youth, intentional programs that meet members where they are, and an unwavering commitment to helping every child discover their full potential. Whether a young person needs academic support, leadership development, or simply a place to belong, the Club offers consistent stability, growth, and joy. For members requiring transportation, we ensure they are safely brought right to the blue doors of their nearest Club, making daily access to our programs a reality.

During the school year, Clubs are open Monday through Thursday from 2:00 PM to 7:00 PM, with extended hours on Fridays and until 8:00 PM for teens. At the core of our mission is a dynamic range of programs designed to meet the diverse needs and interests of our members, helping them grow academically, socially, and emotionally.

Academic Enrichment: BGCBC has developed high-yield educational programs that can be delivered via computer or group settings. Our Youth Education Success (YES) program enhances school learning by focusing on reading and math skills to ensure students' progress through grade levels on time. Y.E.S. begins with Power Hour, a hands-on homework assistance session, followed by skill-building lessons and individualized activities. STEM Club engages youth in hands-on experiments, coding, robotics, and science challenges that foster curiosity and critical thinking. Money Matters equips members with essential financial literacy skills, including budgeting, saving, and responsible spending.

Health & Wellness: Promoting lifelong healthy nutrition and physical fitness is a top priority. Our physical fitness activities cater to all ages and abilities, including group activities, competitive athletic leagues in basketball, football, and cheerleading, and a Summer Swim program offering free swimming lessons. These programs enhance strength and endurance, incorporating fair play, sportsmanship, and teamwork while fostering healthy relationships and a positive use of leisure time. Our programming also promotes wellness through mindfulness and resiliency exercises. Programs like SMART Moves empower youth to make healthy decisions and resist negative peer pressure.

Leadership & Service: Members develop strong communication, planning, and teamwork skills through Keystone Club, Torch Club, and Youth of the Year, where they take on leadership roles and plan community service projects. These experiences help young people grow as compassionate, proactive citizens.

Arts & Creativity: Creativity flourishes through programs like Art with a Heart, our Podcasting Studio, and Recording Studio. From painting and acting to digital art and music production, members explore self-expression and build confidence. Members' artwork, which often explores themes of good character, empathy, civic engagement, and community, is showcased in local, regional, and national exhibits, providing recognition and positive reinforcement.

Workforce Readiness & College Prep: Teens prepare for their futures through Career launch, which includes resume writing, mock interviews, and job shadowing, while Diplomas to Degrees (d2D) supports college readiness with campus tours, FAFSA assistance, and mentorship. Our initiatives address employability by teaching critical soft skills essential for gainful employment, providing teens with tools, encouragement, paid opportunities, and access to professional mentors, equipping them to secure jobs. Youth employment fosters responsibility, organization, time management, financial stability, and work ethic. Research indicates that employment during high school increases future employment prospects and reduces dropout rates. Members are given opportunities for exposure to various fields, training, work experiences, and career exploration.

5. Describe the Applicant Agency's experience in serving the target population and the capacity of the Applicant Agency to undertake the proposed program.

BGCBC is deeply committed to reaching undeserved youth and ensuring equitable access to quality out-of-school time programming. school-time programming. What began as a single Club run by volunteers has grown into a countywide network of 12 Clubs, 6 teen centers, and a staff of 258 dedicated professionals. Our Clubs serve a diverse membership- 65% Black, 20% Hispanic, 6% Multi-racial, 5% White, and 4% Other-with 49% of households earning less than \$30,000 annually, 57% led by single parent households, and 76% qualify for free or reduced lunch. Despite economic disparities, no child is turned away-annual membership is just \$15, with scholarships readily available. Our affordability sets us apart from other out-of-school-time options in Broward County.

26,138 youth were arrested on 42,317 occasions for delinquency during FY 2024-25. That is a 6% arrest increase. Research shows that youth who attend the Club at least 104 times per year (about twice a week) are significantly more likely to avoid risky behaviors, stay on track academically, and maintain healthy lifestyles.

Our impact is measurable and profound. In the 2024-2025 program year:

5. 92% of Club members report being on grade level for age
6. 96% of high school seniors graduated, and 60% enrolled in college or trade school
7. Youth participated in 384,690 hours of Academic Success programming
8. 764,791 healthy snacks and meals were served

-Members spent over 1,925,952 million total hours at our Clubs

While our Clubs provide a strong foundation for youth development, it is through meaningful partnerships with community stakeholders that we're able to expand our impact and deepen our support for the young people we serve. From city and county agencies to mental health providers, law enforcement, food banks, shelters, local businesses, and higher education institutions, our community partnerships enhance our ability to meet the evolving needs of our youth. For 60 years, BGCBC has been a trusted partner in youth development. As we look ahead, we remain committed to removing barriers, creating

opportunities, and ensuring that every young person in Broward County has the tools and support they need to thrive.

Over the years, the Club has served more than 9,000 City of Hollywood youth, delivering results that align with performance goals. Academic support programs help members stay on track with grade-level progression and go on to graduate from high school and earn scholarships. Through dynamic leadership projects and opportunities, youth develop essential life skills and a sense of responsibility to their community. College and career readiness programs broaden their aspirations, with most securing their first internships or jobs through Club support. Physical wellness is also a priority, as members regularly engage in fitness activities and learn healthy lifestyle habits. Funding ensures these outcomes remain consistent year after year, demonstrating the Club's strong return on investment in youth development.

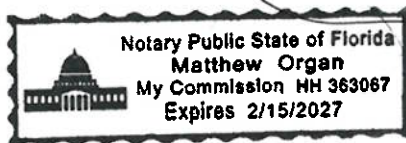

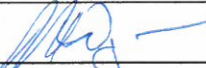
