A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPOINTING SEVEN MEMBERS TO THE AFRICAN AMERICAN ADVISORY COUNCIL

WHEREAS, the City's African American Advisory Council ("AAAC") was created in 1993 by Resolution No. R-93-352 to serve as a liaison between the African American community and the City; and

WHEREAS, the AAAC has been since modified by Resolution No. R-94-106 (establishing the Board criteria), Resolution No. R-97-116 (increasing membership to 12 members), Resolution No. R-2005-293 (increasing membership to 13 and creating two alternate positions), Resolution No. R-2011-333 (increasing the alternate positions to three), and Resolution No. R-2023-168 (eliminating the alternate positions); and

WHEREAS, the AAAC currently consists of 13 members, who must reside or work in the City and either be of African American descent or have extensive knowledge of and interest in the African American community; and

WHEREAS, vacancies exist on the AAAC due to resignations of regular members Chanel Williams and Basil Phillips (whose terms were set to expire June 30, 2026), and the removal for the absences of Cynthia Horat and Suze Dormevil (whose terms were to expire June 30, 2026, and June 30, 2027, respectively); and

WHEREAS, the terms for regular members Joann Fullington-Reese, Joanne Taitt and Marcus Moise will expire on June 30, 2026; and

WHEREAS, the City Clerk provided public notice of the available positions and solicited interest forms from citizens to fill the vacancies; and

WHEREAS, the following individuals have expressed a desire and willingness to serve on the AAAC:
