A RESOLUTION OF THE CITY COMMISSION OF THE CITY
OF HOLLYWOOD, FLORIDA, APPOINTING SEVEN
MEMBERS TO THE MARINE ADVISORY BOARD.

WHEREAS, the City of Hollywood Marine Advisory Board ("Board") was established by the City Commission to develop ways to increase revenue from the marine industries sector in Hollywood; and

WHEREAS, the Board is now comprised of eleven voting Members, with representatives from the following categories: three Marine Industry Professionals, four Residents, three at-large Members and a Youth Member; and

WHEREAS, the Board identifies goals and objectives on an annual basis and provides input to develop ways to increase revenue from the marine industries sector in Hollywood; and

WHEREAS, due to the resignation of David Ide who served in the Marine Industry Professionals category, there is a vacancy and that term expires on June 30, 2026; and

WHEREAS, due to the resignation of Richard Kniffin, who served in the Marine Industry Professionals category, there is a vacancy that must be filled for the remainder of his term that expires on June 30, 2028; and

WHEREAS, due to the resignation of Arthur Mariano who served in the Marine Industry Professionals category, there is a vacancy and that term expires on June 30, 2026; and

WHEREAS, due to the resignation of Ash Chukajim who served in the Hollywood Residents category, there is a vacancy and that term expires on June 30, 2026; and

WHEREAS, John Strader currently serves in the Hollywood Residents category, and his term expires on June 30, 2026; and

WHEREAS, due to the removal of John McCarthy, who served in the Member category, there is a vacancy that must be filled for the remainder of his term that expires on June 30, 2028; and

WHEREAS, Zachary Manasse currently serves as the Youth Member and his term expires on June 30, 2026; and

WHEREAS, the City Clerk provided notice to the public that positions were available and solicited interest forms from citizens to fill available vacancies; and
