

RESOLUTION NO. R-2024-094

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, ADOPTING THE DEPARTMENT OF PARKS, RECREATION AND CULTURAL ARTS SUNSET PARK MASTER PLAN FOR PURPOSES OF FUTURE DEVELOPMENT OF THE FORMER SUNSET GOLF COURSE SITE.

WHEREAS, the City electorate voted to approve a general obligation bond on March 12, 2019, that included the purchase of the privately owned 40+ acre former Sunset Golf Course site for a new public park space; and

WHEREAS, the Department of Parks, Recreation and Cultural Arts ("PRCA") executed a Consultant's Authorization to Proceed with Chen Moore and Associates ("CM&A") to assess existing site conditions, create a preliminary master draft, host public meetings, and finalize a draft master plan for commission consideration; and

WHEREAS, PRCA and CM&A held six in-person meetings, one in each district, along with a Citywide virtual meeting to gather ideas and input from the community at-large; and

WHEREAS, the Sunset Park Master Plan will guide the construction of the City's largest park to serve the community for generations to come; and

WHEREAS, the Director of PRCA recommends adoption of the Sunset Park Master Plan, attached as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA:

Section 1: That the foregoing "WHEREAS" clauses are ratified and confirmed as being true and correct and are incorporated in this Resolution.

Section 2: That it adopts the Parks, Recreation and Cultural Arts Department Sunset Park Master Plan.

Section 3: That this Resolution shall be in full force and effect immediately upon its passage and adoption.

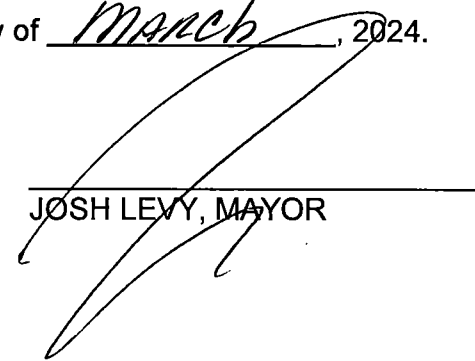

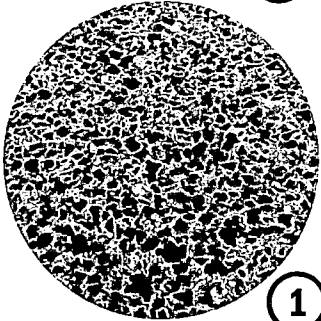
Conceptual Site Plan Elevations
