COMMENCE at the Southwest corner of Block 95; thence N87°54'25"E, along the SOUTH line of said Block 95, 339.45 feet to the POINT OF BEGINNING; thence N02°05'35"W, 17.59 feet; thence S87°54'25"W, 2.50 feet; thence N02°05'35"W, 15.00 feet; thence N87°54'25"E, 15.00 feet; thence S02°05'35"E, 15.00 feet; thence S87°54'25"W, 2.50 feet; thence S02°05'35"E, 17.59 feet; thence S87°54'25"W, along the said south line, 10.00 feet to the POINT OF BEGINNING.

Said lands situate in Broward County, Florida and containing 401 square feet, more or less.
