A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF HOLLYWOOD, FLORIDA, APPROVING THE ADOPTION OF THE WATERWORKS 2050 – 25-YEAR, 5-PHASE SEPTIC-TO-SEWER EXPANSION PROGRAM PER THE SEWER EXPANSION WORKSHOP HELD ON FEBRUARY 18, 2026.

WHEREAS, the City Commission received the Sewer Expansion Workshop Presentation which identifies that approximately 44% of the City remains unsewered, with 17,000 accounts continuing to rely on the septic systems; and

WHEREAS, the Public Utilities Department (“Department”) has determined the need to install sanitary sewer within the outlined 44% unsewered areas; and

WHEREAS, the program for implementation for the septic-to sewer program is subsequently named “Waterworks 2050,” a 25-year program consisting of five phases of five years each; and

WHEREAS, the Department recognizes that the lack of centralized sewer service negatively affects water quality, public health, and groundwater protection, and that long-term planning is required to achieve full conversion; and

WHEREAS, the workshop provides the official basin sequencing developed by the Department for future sewer expansion, including detailed basin level project ordering by program year; and

WHEREAS, the Department desires to establish Waterworks 2050, a 25-year septic-to-sewer program consisting of five phases, to provide a predictable, well-structured and long-term implementation framework; and

WHEREAS, the City hereby adopts the following precise basin sequencing projects, which are fully derived from the workshop documentation and serve as the authoritative order of construction in Appendix A; and

WHEREAS, the Department recommends that the City Commission approve the adoption of the Waterworks 2050 septic-to-sewer program and the implementation of the basin sequencing projects.
